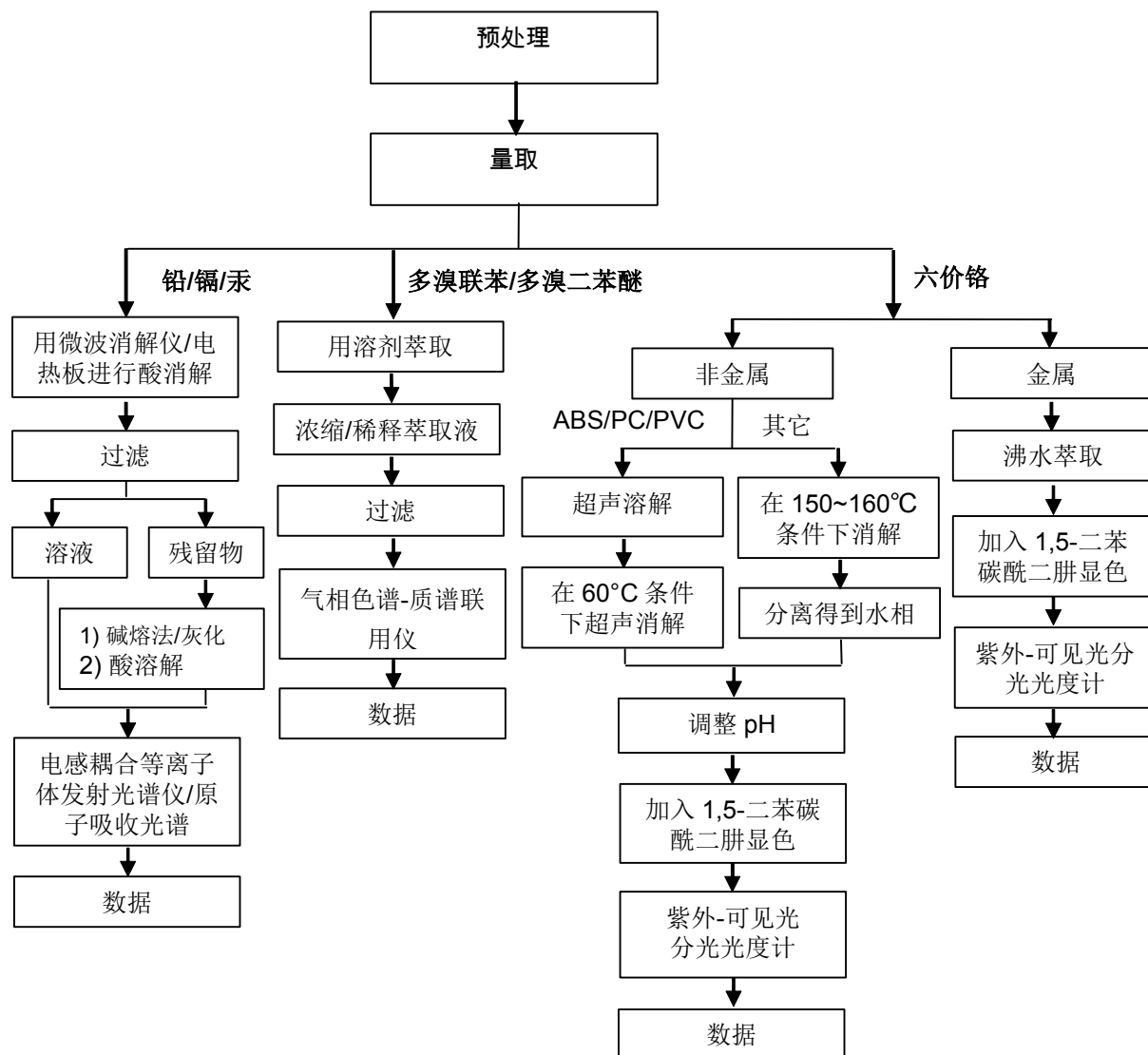

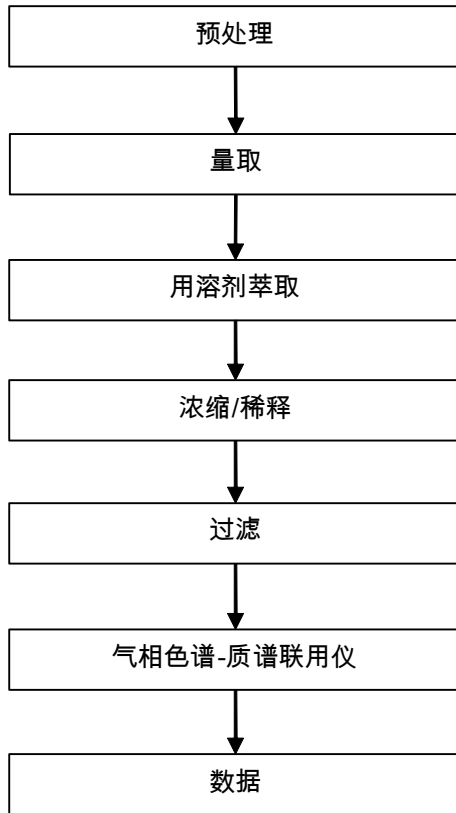
## Pb/Cd/Hg/Cr<sup>6+</sup>/PBBs/PBDEs 检测流程图
